

PROPOSED BYLAWS CHANGE

MIPA's board is asking the membership to approve a change to the organization's bylaws. The change, included below, would allow the board to revise the bylaws without a vote of the membership. This change would bring the bylaws in line with many other nonprofit organizations, including the Journalism Education Association and Colorado Student Media Association, among others, that also allow their boards to revise the bylaws. This follows a trend nationally to give nonprofit member organizations more flexibility in governance.

AT ITS MARCH 2, 2018, MEETING, MIPA'S EXECUTIVE BOARD UNANIMOUSLY VOTED TO ASK THE MEMBERS TO REVISE ARTICLE XI OF THE BYLAWS AS FOLLOWS:

"These bylaws may be amended or new bylaws may be adopted by a majority vote of the board of directors at any meeting. A 10-day notice must be given to the board of specifically worded changes desired, unless the vote by the board is unanimous to approve a change. Bylaws will be made available to all active members."

ABOUT THESE POSITIONS

MIPA's executive board sets policy and direction of the organization. The board includes elected officers (president, first vice president, second vice president, secretary, treasurer and four trustees), the immediate past president and chairpersons of standing committees. All officers are elected for two-year terms. The executive director is an ex-officio (non-voting) member of the board

All members of MIPA's board play a critical role in ensuring the organization meets the needs of its members and that MIPA's activities fulfill its mission to promote and enhance scholastic journalism in the state. All elected officers must be current teachers/ advisers and must be MIPA members. See MIPA's bylaws for more information about these positions and the role of MIPA's board.

FIRST VICE PRESIDENT

MIPA's bylaws state that the First Vice President "shall perform the duties of the President during the latter's absence or at the President's request or in the case of disability. Further, the First Vice President shall have such powers and perform such duties as may be assigned by the Executive Board or the President. The First Vice President shall work with the President and Director in arranging the spring business meeting. In addition, the first Vice President shall be responsible for planning and implementing the adviser's retreat if one is held and will also help the Executive Director plan and carry out both the fall and spring conferences."

The First Vice President is paid \$250 per year for fulfilling these duties for a two-year term. Then, the First Vice President automatically ascends to become MIPA's President in even-numbered years.

MIPA's bylaws state that the president "shall have general and active management of the affairs of the Corporation and shall see that all orders and resolutions of the Executive Board are carried out. The President shall preside at meetings of the general membership, the Executive Board and any other meetings that shall be called. He or she shall be a member of all standing committees, and shall appoint all chairs, subject to the approval of the Executive Board."

The president serves a two-year term and is paid \$500 per year for fulfilling these duties. At the expiration of the president's term, he or she remains on the board for one year as past president.

TRUSTEE

MIPA's board has four trustee positions. Two seats are up for election this year. The bylaws state that trustees "shall be responsible for outreach and will work with the Second Vice President on helping advisers and schools who request such. Trustees will handle elections, on-site contests at the spring conference and take photos (or arrange to have them taken) of MIPA events, such as the spring conference."

BOARD VACANCIES

A vacancy in any office for any reason may be filled by appointment of the Executive Board for the unexpired term.
